Grant-making is structured around four principal goals:


- 1. Innovative Learning Spaces

# per donor





#### What is the organization aiming to accomplish?

The Chatham Education Foundation's vision is to be the leading partner for the School District of the Chathams for collaborating on innovative ideas to enrich education, support future-focused initiatives, and establish a sustainable source of funding through an endowment.

#### What are the organization's key strategies for making this happen?

In addition to annual grant funding of \$80,000, Chatham Education Foundation established an endowment to address increasing strains on the School District of the Chathams. A Permanent Endowment, by producing a reliable stream of income, will bring increased stability and longevity to grant funding, as well as the ability to increase the absolute level of grants. A Term Endowment will help the school district deal with inevitable budget shocks resulting from unpredictable New Jersey State funding levels. We hope that Chatham Education Foundation donors will contribute to the endowment and continue their history of strong philanthropic support for our schools.

#### What are the organization's capabilities for doing this?

The Foundation's Board of Trustees consists of volunteers from all corners of the community and operates independently of the Board of Education, parent-teacher organizations, and booster groups.

#### What have and haven't they accomplished so far?

Assets include an endowment with \$1.9M market value. As a result of new endowment agreements and strong operating financials, the endowment has been built while maintaining significant levels of grant-giving to the school district.





#### GuideStar Charity Check Data Sources

-GuideStar acquires all IRS data directly from the Internal Revenue Service.

-<u>IRS Publication 78 (Cumulative List of Organizations)</u> lists organizations that have been recognized by the Internal Revenue Service as eligible to receive tax-deductible contributions.

-The <u>IRS Internal Revenue Bulletin</u> (IRB) lists changes in charitable status since the last Publication 78 release. Between the release of IRS Publication 78 and the subsequent IRS Internal Revenue Bulletin, the IRB date will reflect the most recent release date of IRS Publication 78.

-The <u>IRS Business Master File</u> lists approximately 1.7 million nonprofits registered with the IRS as tax-exempt organizations.

-The <u>IRS Automatic Revocation of Exemption List</u> contains organizations that have had their federal tax-exempt status automatically revoked for failing to file an annual return or notice with the IRS for three consecutive years.

-The Foundation Status Code is a value derived by mapping the codes found on the <u>990PF filing instructions</u> to the corresponding codes in the IRS BMF. Note that not all codes are able to be mapped due to insufficient data.

-The Office of Foreign Assets Control (OFAC) <u>Specially Designated Nationals (SDN) list</u> organizations that are owned or controlled by targeted individuals, groups, and entities, such as terrorists or narcotics traffickers. Their assets are blocked and U.S. persons are generally prohibited from dealing with them.
